- Non-SVRA drivers must include a copy their current competition license & medical forms with their entry. Entrants that do not hold a Vintage Racing License or who have not competed in a Vintage Event are required to participate in the SVRA Driver Orientation Program.
- As of July 1, 2013, it is MANDATORY that all competitors use a "Head and Neck" Restraint System that meets the SFI 38.1 Standard.
