Eligibility:

1. GTP/Group C, ALMS, PSCR, WSC and Grand Am, Lemans-type Prototype cars SCCA P1 and P2 as raced from 1981 to specified cut-off date.

Modifications:

As listed in the SVRA General Rules and Regulations, the Supplemental Rules, the SVRA Tire Regulations and any period rules that are deemed appropriate

Group 11 cars are expected to have only period-correct equipment and specifications. **All GTP classes must run period-correct restrictors and weights.** Certain Classes within this Group may be required to update Safety Equipment as specified in the SVRA Rules and Regulations. It is the responsibility of the competitor to provide documentation for any specification that is not generally considered appropriate.

Group 11 cars may be subject to weight adjustment to equalize competition.

Group splitting if necessary as follows:
11a – Engine displacements larger than 3.0L. Turbocharged engines may be classified in either appropriate class.
